- We have [a new website!](#) During Spring Break, our Student Affairs Communications Team successfully transitioned us to our new design. Please give us patience and grace as we transfer information and develop content, which includes photos and videos of your organization. If you have any photos or videos from this past year and/or moving forward, please e-mail it to us with detailed information about the content to studentengagement@stanford.edu.
- As you **transition your leadership** please work to **share any historical records** and **review your finances** of your organization with your newly elected student leaders over the next 10 weeks of Spring Quarter. It is important that you pay all of your **outstanding financial obligations** as soon as possible, and not wait until the end of the quarter.

- The Stanford Fund (TSF) application process will be coming up in Spring Quarter. Please review [key information](#) to be considered for TSF funds.
- The [Solidarity Fund](#) application is open for the Spring quarter. Funding can be utilized for student organizations planning a program geared towards addressing anti-Black racism. Here is the [application](#) to request funding for an event.
- The [annual registration process](#) for student organizations, excluding social Fraternities and Sororities, opens **Monday, April 4, 2022** in [CardinalEngage](#). The deadline to register is **Sunday, June 19, 2022**. This annual process is required to be a recognized student organization, operate in the name of Stanford and use university and ASSU resources, including funding and space. Registrations will be processed **starting June 19**. If you need to be approved before June 19 to give incoming officers **access to our systems**, which includes giving your new Financial Officer access to the GrantEd Banking System, please email studentengagement@stanford.edu. Please note that once registration is approved in CardinalEngage, your outgoing leaders will lose access to CardinalEngage and GrantEd immediately.
